Sunshine Update



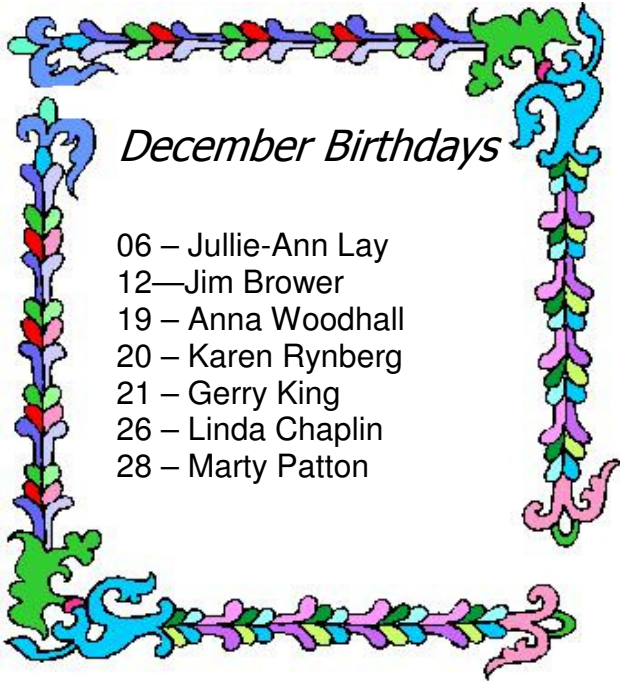
Reba Rohleder is not doing well with her cancer. Please keep her and family in your prayers.

November Program

Our November program was quite interesting. Hope you got to see it. Rich Dvoracek talked on one of our favorite subjects...Gold! He went into describing how it is formed and the different ways it intrudes into the mother rock. Not as simple as you would think. He brought with him, a cube measuring about 1 1/2' square and said it would weigh a ton if it were gold. He also had some excellent specimens of gold in different forms. Rich also talked about how mining for gold evolved into what it is today. Following the program, club members got to look at the specimens up close and through a microscope.

December's Birthstone is Turquoise

Turquoise is one of the earliest used gemstones and is the one most worn in the United States.

Turquoise is a soft, porous, opaque stone that ranges in color from blue to green. It is a mineral that is deposited by water solutions, and comes in various forms. It can be found in large pieces, but is most often found imbedded in veins of rock found near the surface. It is also found in the form of nuggets, and sometimes forms in cavities lined with quartz crystals.



The color of turquoise is determined by its ingredients. A combination of copper and aluminum produces a blue stone, while copper and iron can make it green instead. Some turquoise is one solid color, but not often, and that is what makes it so unique. Factors effecting the appearance other than color include inclusions, impurities, and the environment while it developed.

Most people think that turquoise is found only in the United States, but it comes from many locations around the world. It can be found in Tibet, China, Persia, Australia, Mexico, and South America as well as our own Southwest. Evidence of its use for jewelry dates back to the Egyptians, some 70 centuries ago. Turquoise jewelry was found on the arm of a mummified Egyptian queen.

Turquoise is a favorite stone of the Native Americans. Some Southwest turquoise mines were worked by them before the time of Christ. They create many beautiful styles of jewelry, setting the turquoise in silver. Many fortunate people own and wear this wonderful jewelry. Some have learned to create their own unique turquoise jewelry. Most turquoise is set in silver, however it also looks elegant when set in gold.

I recently returned from the Fall CFMS Directors Meeting in Visalia. I arrived on Friday in time to attend the Cracker Barrel, which is an informal get together the evening before the Director's Meeting on Saturday. On Saturday evening Julie and I also attended the Banquet. One of the highlights was the installation of the 2010 CFMS Officers.

Directors Meeting:

Following all the formalities, a quorum was confirmed with all the Officers and 56 clubs in attendance.

Actions of the Executive Committee were reviewed and voted on. These included:

- Establishing the second weekend of November 2010 as the next fall CFMS Directors meeting.
- Setting up an Ad hoc Electronic Newsletter and Communications Committee.
- Contracting Diamond Dan Publications at a discounted rate for a two year subscription available to clubs.
- Rewording CFMS Show contracts to say up to \$2000.00 seed money will be available to host societies.
- An Ad hoc Web Site Contest Committee be formed.

There were two applications for CFMS membership. They were Bakersfield Mineral Mites with 22 members, and Scott Valley Gem & Mineral Society with 63 members. Both were approved and welcomed into CFMS. North Island Gem & Mineral Society recently disbanded.

The 2010 Combined AFMS/CFMS Show has lots of great things lined up. The show, "Hidden Treasures", will be in La Habra and Whittier. The show will be spread out between two facilities, which are close to each other. It will run from June 18th, 19th & 20th, 2010. One neat thing about this show besides being a joint national/state show is that is right next to Anaheim and all the southern California attractions.

The 2011 CFMS show will be in northern California. It will be a joint venture put on by the Superior California Gem & Mineral Association. "Northern California Treasures" will be held at the fairgrounds in Anderson.

Nominating Committee Chairman Frank Mullaney introduced the 2010 nominees and there being no positions in contention, they were voted in by acclamation. New Officers are as follows: Fred Ott, President; Jim Brace-Thompson, 1st Vice President; Susan Chaisson-Walblom, 2nd Vice President; Bud McMillian, Treasurer; and Jennifer Haley, Secretary. Topping of the compli-

ment of officers is Pat LaRue, Executive Secretary.

Next came the Committee Reports. The following are highlights that may be of interest to club members:

- Earth Science: Camp Paradise is changing hands again to a Foster Care organization. CFMS has been asked to help partner on a limited basis. They want CFMS to give a class once a month about earth science. Also being considered, is a new building to store earth science equipment and for seminars. More to come on this developing venture.
- Insurance: Be sure forms are submitted along with membership count and dues no later than December 31st.
- All American Award Program Report: Three clubs submitted entries this year. Sutter Buttes Gem & Mineral Society earned a plaque in CFMS and a silver award in the AFMS judging for the small club category. Under the large club category, there were two entries, El Dorado Mineral & Gem Society and Mother Lode Mineral Society. The El Dorado club won a plaque from CFMS and gold from AFMS, while the Mother Lode club won a certificate from CFMS and the gold from AFMS. All clubs are urged to enter.
- Bulletin Aids: With the upcoming contest there will be a few changes, mostly because of the combined AFMS/CFMS show. Be sure to check the latest rules for submissions.
- Podium People: There are a few changes to the list. Check on the CFMS website for the current information.
- Slide, Video and CD-ROM Report: The loan program seems to remain at the same volume of loans as in previous years, with more interest in the DVD programs over slides and videos. There will be a new catalog coming out but it was delayed to include the new program winners from AFMS. The current catalog is available on the CFMS website under the manuals category.
- Camp Paradise Raffle Ticket Drawing: There was quite an interest and a large number of tickets sold for the free week at Camp Paradise with over \$2,345.00 taken in. Instead of one ticket being drawn, there were two. Winners were Merryan O'Neill and Gail Lack. Of the clubs that sold enough tickets to qualify for the club drawing, El Dorado Mineral & Gem Society was the winner. To make sure the drawing wasn't rigged, Doug Arnold of the Victor Valley Gem and Mineral Club drew the winning tickets. Doug's eyesight is so poor, he couldn't possibly cheat. The raffle went over so well, it will be held again for next year.

Be Safe - Be Well

What is in Your pocket?

Many times back on the farm my mother asked me this question. I was expected to give her an inventory which always began with my pocket knife which I have always carried except on airplanes and in the courthouse. I also carried rocks or arrowheads (now isn't that a surprise?), Minnie balls or grapeshot which littered our farm left from the Civil War battle there and anything else that I had found fascinating. I was rarely inclined to tell her if I was also carrying any small snakes or other varmints since her sense of humor definitely had limits. Much later I finally learned that she was simply trying to figure out what was wearing out my pants pockets so quickly.

My reason for discussing things carried in pockets is to talk about things that should be carried and some of the things that shouldn't. Many industrial plants have strict rules against carrying disposable lighters. When working in areas where flammable gases or liquids are present, it is possible to start a fire simply by leaning against a work bench and thereby pressing the lighter. This is not at all uncommon and can result in burns or even explosions. Other bad things to be avoided in pants pockets include sharp objects such as files, scribes, syringes, pencils or ball point pens and glass which may break.

Mother Road National Monument Proposal Threatens Classic Mojave Collecting Sites

A recent report notes a proposal for the "Mother Road National Monument" to make the section of historic Route 66 between Needles and Barstow a National Monument. The proposal is being pushed by the Sierra Club, Nevada Desert Committee, CWC, Wildlands Conservancy, and Route 66 preservationists, including the Needles Downtown Business Alliance, which meets twice monthly, on the first and third Thursday, at 11:30 AM in the Wagon Wheel restaurant along Needles Highway. Senator Diane Feinstein is proposing to make this a national monument (Mojave National Monument) and to be 70 miles long and 20 miles wide (10 miles on both sides of US Route 66). That pretty much ends any collecting at Lavic Siding, Cady

Mountains, Bristol Mountains, Marble Mountains, Clipper Mountains, Piute Mountains, Sacramento Mountains, Providence Mountains, Granite Mountains, and all valleys in between. So be aware and be prepared to loose more ground, again, unless we jump in the fire feet first and identify the collecting areas and get them and their roads identified and preserved as national collecting sites for future generations and educational purposes. If this turns your stomach, become proactive now!

CFMS Field Trip to Cady Mtns North

CFMS Field Trip South Co-Chairs - 2008, 2009

This trip is open to all CFMS members and guests that agree to abide by the AFMS Code of Ethics, the directions of the field trip leader, and practice safe rockhounding. A Consent and Assumption of Risk Waiver of Liability form must be signed upon arriving at the campsite.

Be aware that this is a remote and undeveloped area. Collect responsibly.

WHEN: December 12-13, 2009.

WHERE: North Cady Mtns near Afton Canyon area, off Basin Road exit by I-15 about 45 miles east of Barstow.

DIRECTIONS: Take the Basin Road exit off I-15 about 45 miles east of Barstow and turn right (south) for 1.3 miles to fork in road. Take the left road for 3.8 miles to the railroad tracks and cross the tracks to the campsite. Use caution.

MATERIAL TO COLLECT: Adam Dean's favorite spots for agate, jasper, calcite, green and purple fluorite, sagenite, opalite and much more.

SPONSOR: California Federation of Mineralogical Societies (CFMS).

LEADERS: Adam Dean and Shep Koss

OVERNIGHTER This trip is an overnighter with dry camping near the railroad side tracks off Basin Road.

The campsite can accommodate RVs and tents. This is dry camping with no facilities whatsoever. Bring water, firewood, clothing for any type of weather hot or cold wet or dry, food and a full tank of gas. High clearance and 4WD recommended for all sites. 2WD ok to the camping area if driven with care as many spots may have windblown sand. Roads to some sites may have deep sand. Potluck dinner Saturday night - bring a contribution.

TREAT THE DESERT WITH RESPECT: Please help protect our deserts, *tread lightly, and pack-out what you packed-in!* All those attending the collecting trips will be required to fill out a Liability Waiver form.
