To California ALAA Members and Rockhounds,

The Bureau of Land Management (BLM), Barstow Field Office is initiating a joint management plan for the Amargosa Wild & Scenic River (WSR) and Amargosa River Area of Critical Environmental Concern (ACEC). The WSR and ACEC are located in northeastern San Bernardino and southeastern Inyo Counties, Calif., near the communities of Tecopa and Death Valley Junction. The plans will guide management decisions and actions affecting the river and surrounding areas. The BLM is inviting public input to help identify resource conditions and management issues to be addressed in the joint plan.

The BLM anticipates that the planning process will take approximately one and a half years to complete. While input throughout the planning process is welcome, comments received during the initial scoping period - September 1-30, 2011 - will prove more beneficial to the planning process.

Comments may be submitted in writing to Chris Otahal, BLM Barstow Field Office, 2601 Barstow Road, Barstow, CA 92311; however, e-mails to amargosa@blm.gov are preferred. A short presentation regarding the planning process will be presented at the scoping meeting and written comments will be solicited, but oral comments will not be taken.

The BLM will hold a public scoping meeting in Tecopa, CA, Wednesday, September 14, 2011, from 7-8 p.m., to garner comments for developing a management plan for the Amargosa River area. The public scoping meeting will take place at the Tecopa Community Center, 400 Tecopa Hot Springs Road, Tecopa, CA 92389.

BLUERIBBON COALITION ACTION ALERT!

National Legislation Impacting California Recreationist

As Western Representative for the BlueRibbon Coalition, I am deeply concerned that anti-access groups and their supporters in Congress will try and have Section 446 stripped when the House considers H.R. 2584, the Department of the Interior, Environment and Related Agencies Appropriations Act.

Section 446 is Congressman Wally Herger's pro-access language that attempts to fix some anti-access tenets from Region 5's version of the Travel Management Rule. Section 446 is almost identical to bill language in Herger's H.R. 242 that was introduced in February 2011.

The main issue is the Forest Service has proposed to close hundreds if not thousands of miles of old logging roads to non-street legal OHV use. This access is important for continued recreational access, connectivity between existing OHV trail systems, and the rural economy.

BRC is asking you to contact your local House member and ask them to oppose any effort to strip Section 446 from H.R. 2584. If you need help identifying your U.S. Representative, the BlueRibbon Coalition has a handy tool in our Rapid Response Center at www.sharetrails.org/rapid_response/. All you need to do is type your zip code in the "Contact Lawmakers" box and click GO. Click on your representative's name and then click on the "Contact" tab to locate their phone number.

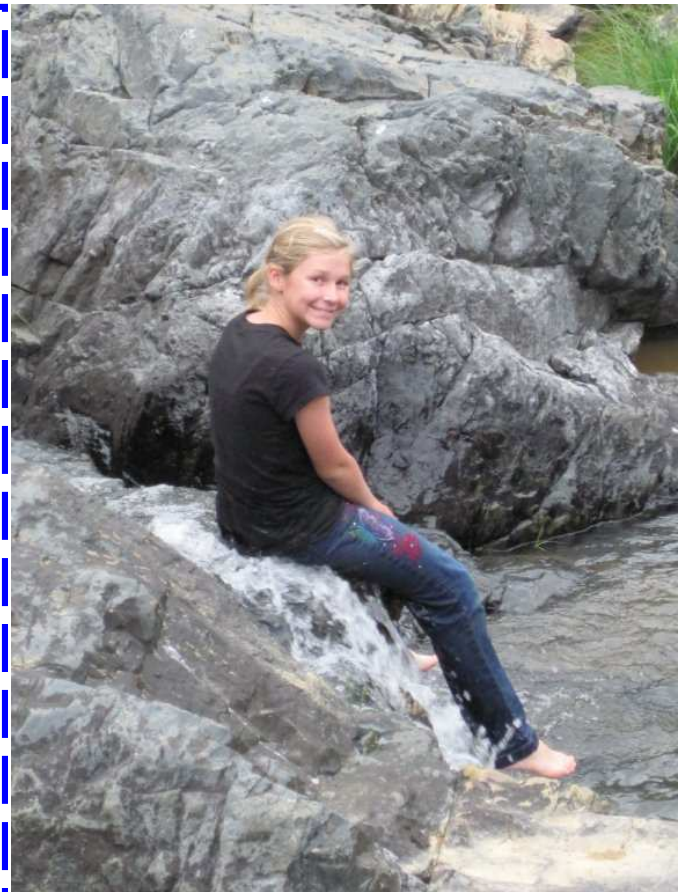

COLLECTION MATERIAL – jasper, agate, rhyolite (wonderstone), leaf fossils are a possibility

PROPOSED SCHEDULE - Sat 9/10/11 (Frenchman's) jasper agate, Sun 9/11/11 rhyolite, agate (leaf fossils possible)

MEET – Saturday, 9am Grimes Point rest area parking lot near Hwy 50. Sunday: Meet at 8:30am Grimes Point rest area parking area (The leaf fossils are out of Fallon).

DIRECTIONS TO SITE/CAMP - The turnoff to Grimes Point is 10.2 miles east on US Hwy. 50 from the intersection of E. Williams and Maine (Hwy. 95 and 50) in downtown Fallon. Follow the pie plates to the camp site past the Grimes Point rest area. If it is very hot, the RV park or motel are suggested.

VEHICLE REQ'S – 4 x 4 or high clearance with posi-traction or all wheel slip prevention equipped vehicles.

CAMP/FACILITIES – RV park and motels in Fallon. Dry camping past Grimes Point rest area near Wonderstone Mtn. (no water, power or rest rooms at camp site)

SAFETY CONCERNS – Lookout for rattlesnakes and scorpions. Dehydration. Pack plenty of water to collecting sites. The hillsides may be steep and rocky. Safety glasses are recommended when breaking rocks.

CLIMATE/WEATHER – May be quite hot, or pleasant, at this time of the year. May have cool evenings.

CLOTHING –Sun protection – hat, sunscreen. Bring long pants and good boots.

OTHER REMARKS – It is all BLM land. Collecting has to be limited to a reasonable amount for personal use. Bring your club badges. Bring walkie talkies if you have them.
